No. 2-Leg./2023.- The following Act of the Legislature of the State of Punjab received the assent of the Governor of Punjab on the 17th day of March, 2023 is hereby published for general information:-

THE PUNJAB APPROPRIATION (NO. 2) ACT, 2023 (Punjab Act No. 2 of 2023)

AN

ACT

to authorize the payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Punjab, for the services and purposes during the financial year 2022-2023.

BE it enacted by the Legislature of the State of Punjab in the Seventy-fourth Year of the Republic of India as follows:-

Short title. 1. This Act may be called the Punjab Appropriation (No. 2) Act, 2023.

Issue of ₹ 36795,87,71,000/out of the Consolidated Fund of the State of Punjab for the financial year, 2022-2023.

Appropriation.

₹ 2. From and out of the Consolidated Fund of the State of Punjab, there may be paid and applied sums, not exceeding those, specified in column 5 of the Schedule, appended to this Act, amounting, in the aggregate to a sum of ₹ 36795,87,71,000/- (Thirty six thousand the seven hundred ninety five crore eighty seven lac and seventy one thousand rupees only) towards defraying several charges, which will come in the course of payment during the financial year 2022-2023 ending on the thirty-first day of March, 2023, in respect of the services and purposes, specified in column 2 of the said Schedule.
3. The sums, authorized to be paid and applied from and out of the Consolidated Fund of the State of Punjab

by this Act, shall be appropriated for the services and purposes, specified in the said Schedule, in relation to the financial year 2022-2023.
